SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- The College login will be closed after the last date.
- In case the fee is not remitted to the O.U. A/c. OR if online EAFs are not submitted on or before due date, even if fees remitted into fund account within due date. (Late submission of forms by the College beyond the date prescribed attracts penalty @ Rs.1500/- per day and to be borne by the college)
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.
- The Principals are requested to transfer Consolidated exam fee amount into The Registrar, Examination fee fund, O.U., A/c No. 52198262033 (SBI, O.U. Branch, IFSC Code "SBIN0020071"), O.U. through online payment in EAF login.

Conditions:-

1. *All the Principals are requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal will be held responsible for the issue of hall ticket to the non-eligible candidates.*
2. ***DO NOT collect the Exam fee from Visually/Physically Challenged and Hearing Impairment students as per O.U. Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008.** A Xerox copy of medical Certificate confirming their status to be attached. (Minimum percentage of disability must be 40% & above.) Visually/Physically Challenged and Hearing Impairment students applications forms should be submitted separately along with separate Nominal Roll.*
3. Any discrepancies with regards to the Candidate's data such as Internal marks, Practical etc. should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement before declaration of the results. After declaration of the results, queries will not be entertained.
4. *The Principals will be held responsible for any lapse in transfer of amount from the banks to the "Registrar, O.U. Exam Fee Fund Account".*
5. *The Students who were admitted in 2022-23 & 2023-24, who have not completed their course within the stipulated time of 'N' years and fall under the +2 (plus two) years extension period are required to pay an additional fee of Rs. 500/- along with the prescribed semester examination fee.*
