SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- In case the fee is not remitted to the O.U. A/c. **OR** if online EAFs are not submitted on or before due date even if fees remitted into fund account within due date. **(Late submission of forms by the College beyond the date prescribed attracts penalty @ Rs.1500/- per day and to be borne by the college)**
- All the Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.
- The Principals are requested to transfer Consolidated exam fee amount into The Registrar, Examination fee fund, O.U., A/c No. 52198262033 (SBI, O.U. Branch, IFSC Code "SBIN0020071"), O.U. through online payment in EAF login.

Conditions:-

1. *The students who were transferred from the University Jurisdiction and other Universities their examination forms should be submitted separately with the approval of the competent authorities like Commissioner of Tech. Education, Govt. of T.S. and Director, Directorate of Academic Audit, O.U. with allotment of H.T.No.s.*

2. *The Students who were admitted in 2020-21 & 2021-22 and (lateral entry students admitted in 2021-22 & 2022-23) who have not completed their course within the stipulated time of 'N' years and fall under the +2 (plus two) years extension period are required to pay an additional fee of Rs. 500/- per subject along with the prescribed semester examination fee.*
3. **Not to collect the Exam fee from Visually/Physically Challenged and Hearing Impairment students** as per O.U. Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox copy of medical Certificate confirming their status. (Minimum percentage of disability must be of 40% attached to the application forms.) **Visually/Physically Challenged and Hearing Impairment students applications forms should be submitted separately along with separate Nominal Roll.**
4. *Any discrepancies with regards to the Candidate's data such as Internal marks, Practical, Viva-voce and Projects etc. should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement within one month of declaration of results. After one month, queries will not be entertained.*
5. *The Principals are advised not to submit hard copies of EAF application forms to the Examination Branch, O.U. The principals are providing only the online payment receipt accompanied by a college letterhead that includes all the required details by the concerned sections of the Examination Branch. The Principals can verify the approval status in their College Logins.*
6. *The Principals will be held responsible for any lapse in transfer of amount from the banks to the "Registrar, O.U. Exam Fee Fund Account".*

Examination application forms will not be accepted without fulfilling the above Conditions.
