- Each party shall ensure that the other is not put to any liability for any actions of the 3.1 one party.
- Each party represents that they have the full power and authority to enter into this 3.2 MOU in general.

4. General

- Both parties will designate a representative from its side who will be the primary 4.1 point of contact on behalf of that party.
- Both parties shall not use the name of the other in any advertisement or make any 4.2 public announcement without the prior written approve of the other.
- Any dispute under this MOU will be settled in Hyderabad through arbitration, if 4.3 necessary.
